Kim's research explores the relationships between energy poverty (fuel poverty), energy use behaviours, energy efficiency of housing and buildings, and the important interactions of these with health and wellbeing. She leads research exploring the impact of COVID-19 restrictions on home energy use in New Zealand and health outcomes of the government's Winter Energy Payment, and is a collaborator on an international project exploring energy poverty in Canada. She holds a Marsden Fast Start research grant: Heating Up, Cooling Off: Household management of summer heat flows. She has experience in energy poverty and health research, consumer experiences and impacts of prepay electricity, involving young people in the research process, and exploring energy use among people who work from home. Kim has expertise in the design and use of qualitative methods, surveys, mixed methods, and participatory research methods; linking and integrating diverse datasets to produce robust evidence on the extent and health impacts of energy poverty, and pioneering digital research methods for public health and energy research.

After a long career in Financial Services across a range of organisations throughout New Zealand, Christina moved to MSD and the Public Service in 2019. As CEO, Sumaria Beaton is the main leader and driver of Invercargill-based Awarua Synergy. The Southland business grew from its roots 18 years ago as a Marae hapu-based social enterprise, based at Te Rau Aroha Marae in Bluff. Awarua Synergy has now insulated more than 10,000 Southland homes, businesses and farms, and has expanded into the home heating market as part of its mission of 'warming and eco-powering our Deep South'. Sumaria is passionate about education within this sector, delivering Kaupapa Māori Energy Efficient Healthy Homes education throughout New Zealand, including the Chatham Islands, called Hauora Homes HEMI training. This training covers the vital importance of insulation and energy efficiency in homes.



Anaru Marshall

Chief Executive, Ngāti Maru

Anaru has been employed by the Trust since the beginning of 2019 as Lead Negotiator and Transition Manager for Te Rūnanga o Ngāti Maru.

Prior to this role he was the Chief Executive and then Relationship and Development Manager for WISE Better Homes for more than 10 years.

While working at WISE Anaru was very busy as the lead negotiator for Ngāti Maru.

Anaru has extensive experience across financial services, running his own business as well as working for commercial and not-for-profit charitable trusts. He is also a Trustee of East Taranaki Environment Trust (ETET).



Alana Ruakere

Tui Ora is the largest kaupapa Māori hauora and social services provider in Taranaki, employing 185 kaimahi and offering 40 whānau-centred services to the Taranaki community. Alana has had a long and distinguished career in the public service, particularly in the health sector. Prior to joining Tui Ora Alana was the Director of the Crown Response Unit managing the Governments response to the Royal Commission of Inquiry into Abuse in Care. She has also held senior policy and managerial roles with the Ministry of Health, Te Puni Kōkiri and the Ministry of Social Development. Alana is from Taranaki and was educated at Ōpunake High School and New Plymouth Girl's High School. Alana and her whānau whakapapa to Te Atiawa and Taranaki iwi.



Gaylene Leabourn

Healthy Homes Initiative National Lead, Te Whatu Ora

Gaylene Leabourn is the Healthy Homes Initiative national lead for Te Whatu Ora. Currently based in Tāmaki Makaurau / Auckland. She was born in Te Tai Tokerau/Northland and hopes to move back there soon. She has worked in health her whole career, beginning as a nurse and working in the community. She's also building an eco community on her land in Farewell Spit to decarbonise her own life.

Convenor of the Energy Wellbeing Evaluation Consortium

Nina is a social scientist specialising in energy sector decarbonisation. For over 15 years, she has focused on the role of clean energy in supporting social and economic development, and promoting energy equity. Currently, Nina is seconded to the Ministry for Energy and Resources, supporting the work of the Energy Hardship Expert Panel. Privately, she is also on the Board of the Energy Evaluation Asia Pacific network, and convenes the Energy Wellbeing Evaluation Consortium. Previously Nina was based in Europe, primarily at the IEA, where she led innovative work into the benefits of energy efficiency for alleviating energy poverty. Co-Founder / Director, Sustainability Options

Nik is currently a co-founder and Director of Sustainability Options, an altruistic business dedicated to improving housing conditions for all New Zealanders. Nik has been involved in the sustainable impacts of housing for over 15 years, and during this time has personally visited thousands of homes around the Bay of Plenty, and has had the privilege of being part of various teams impacting tens of thousands of homes. Alongside continuing to visit homes and finding ways to improve housing conditions, Nik has been a national HPA trainer for the past 8 years, part of Te Whatu Ora's Healthy Homes initiative Roopu leadership group and the Healthy Homes Initiative national training and coaching support. Nik and the team he works with are passionate about a recipe of: conversations, journey, education and intentional capacity building to change the housing culture in New Zealand from one of accepting poor conditions to aspiring and achieving excellent conditions.

Advocating for change in the building financial capability sector to reduce poverty and hardship in Aotearoa. Specializing in hardship from a Māori and Pasifika community perspective.

Moana is of Ngai Tūhoe and Cook Island descent, born and bred in the Eastern Bay of Plenty, from Ruatoki. Her role as the Business Analyst for her iwi-Ngai Tūhoe supported the achievement of the most unique tribal settlement nationally and internationally. Te Urewera Act 2014, that recognises in law Ngāi Tūhoe homelands, an identity of it's own as a legal person in it's own right, grounded in the principles of: Land – Justice – Livelihood – Energy. Her passion and values are grounded in her Tūhoetanga and the revitalization of language, culture, and self-determination.

Dr Julie MacArthur

Associate Professor / Canada Research Chair in Reimagining Capitalism, Royal Roads University, Canada

Dr Julie MacArthur is an associate professor and the Canada Research Chair in Reimagining Capitalism at Royal Roads University in Victoria, Canada. Her work investigates the political economy of low carbon transitions, with a particular focus on how grassroots and community-led initiatives can scale up to make radical and transformative impacts to both adaptation and mitigation.
